It was observed that unit was not turned on. Chicken was re-heated to 165F before being placed in hot holding again. Eggs were removed. See VC&D.

		Observed smoothie mix at 57F and frappe mix at 58F in cold-holing unit. Maintain foods in cold holding at 41F and below. Thermometer in unit measured 60F, and it was determined that unit was not maintaining temperature of 41F and below. Potentially hazardous foods will be stored in walk-in cooler until the unit is repaired and functioning properly.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))
