6. ADEQUATE HANDWASHING FACILITIES SUPPLIED & ACCESSIBLE

POINTS 2	Compliance date not specified	Inspector Comments: Observed leak at cold water line at handwash sink. Repair immediately.
	Not In Compliance	

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

7. PROPER HOT AND COLD HOLDING TEMPERATURES

POINTS 2	Compliance date not specified	Inspector Comments: Observed raw beef, raw chicken, fried cream cheese wong tons and cooked noodles holding at 46-49F inside the reach in cooler near the woks. Discontinue holding potentially hazardous food at unapproved temperatures.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

9. PROPER COOLING METHODS

POINTS 2	Compliance date not specified	Inspector Comments: Observed cooked noodles at 46F inside deep strainers inside the walk in cooler. Properly cool all potentially hazardous food items. Training provided.
	Not In Compliance	

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

POINTS 2	Compliance date not specified	Inspector Comments: Observed employee wipe food preparation table with 50ppm chlorine. Ensure all food contact surfaces are sanitized with the appropriate concentration of sanitizer. Employee then wiped the table within 100ppm chlorine.
