POINTS 1	Compliance date not specified	Inspector Comments: Observed several pieces of essential kitchen equipment in disrepair including 2 reach in refrigerators, 1 blast chiller and 2 ovens. Repair IMMEDIATELY.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)
