Provide on the questionnaire whether the customer is pregnant, allergic to latex/antibiotics, is a hemophiliac or has any other bleeding disorder and whether he/she may have cardiac valve disease and herpes. Also include (D3-D4) a question about currently using antibiotics and other risk factors for bloodborne pathogen exposure.
