POINTS 4	Compliance date not specified	Inspector Comments: Observed the employee grab a paper towel after washing hands; then proceeded to wipe nose with the paper towel and continue to dry hands with the same paper towel. Ensure hands are washed with proper procedures. Refrain from using the same paper towel to wipe face for drying hands during handwashing. Employee was notified and hands were washed.
	Complied on 8/8/2013	
Observed employee use hand sanitizer without first washing hands. Wash hands thoroughly prior to use of hand sanitizer. Ensure employees are aware that the use of hand sanitizer does not substitute for adequate handwashing procedures. Wash hands with soap and warm water (minimum 100F) for 15 to 20 seconds. Ensure hands are dried with a single-use/disposable cloth.		

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)
