**7. PROPER HOT AND COLD HOLDING TEMPERATURES** **⚠ CRITICAL ⚠**

<b>POINTS</b> <b>4</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed major temperature violation in the large refrigeration unit with drawers at front cook line: Raw pork and raw beef (held for over 3 hours) temped at 52F and 54F; diced ham and cooked sausage (held for over 6 hours) temped at 58F and 65F; sandwich ham and turkey (held for less than 2 hours) temped at 55F and 55F; tuna salad and unshelled boiled eggs (held for over 6 hours) temped at 54F and 53F; hash brown (held for over 3 hours) temped at 59F. VC&D as correction.  Air in the unit temped at 60F. Repair the unit soon as possible to be able to hold food at or below 41F. Inspector will follow up in 24 hours.

**Violation Description:** Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

**9. PROPER COOLING METHODS** **⚠ CRITICAL ⚠**

<b>POINTS</b> <b>4</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed covered and stacked containers of Spanish rice and beans (both cooked yesterday) temped at 49F, 47F and 48F. Cool potentially hazardous food (PHF) from 135F to 70F within 2 hours and then to 41F within total 6 hours. Avoid cooling very hot food in covered and stacked containers. VC&D as correction. (Note: Air in the unit temped at 43F at this time.)  Observed fried chicken (cooked near 4 hours before) temped at 74F in a refrigeration drawer at front cooking area. Recommend to cool PHF in larger refrigeration unit. VC&D as correction.

**Violation Description:** All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

**Violation Description:** An accurate easily readable metal probe thermometer suitable for measuring temperature of food shall be available to the food handler. A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)

**Violation Description:** The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

**Violation Description:** This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.

Following food was discarded due to violation #7: 2lbs of raw pork, 3lbs of raw steak, 1lb of diced ham, less than 0.5lb of cooked sausage, 2lbs of hash brown, 1lb of tuna salad, and about a dozen of boiled eggs.

**Violation Description:** Operator has voluntarily consented to the condemnation and destruction of food as said material being unfit for human consumption or otherwise in violation of California Health and Safety Code, Division 104, Part 5, Chapter 1 through 8, the disposition of which is provided for by Chapter 8, Article 3, Section 111895.
