Inspector Comments: This facility has not complied with the requirement to submit the completed missing food worker card sheet to the health dept. The facility was given 7 days to comply with this requirement during a charged inspection on 9/12/13. The owner, Louie, spoke to Joshua Sarmiento, the contact person for food handler card matter last week but the compliance has not been met. This facility is given another 7 days to submit the paper work. Inspector called Louie and left message on his phone regarding this issue. The paperwork has to be received and cleared by the health dept by October 2, 2013. Non compliance will result in office hearing, permit suspension or further legal action.

Violation Description: During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.

Overall Inspection Comments

Observed no food manager's certification or proof of enrollment to a manager's certification class. A charged re-reinspection is scheduled on or after 10/2/13. Please have the certificate or proof of enrollment on that day to avoid another charged inspection.
