**Violation Description:** A complaint report has been received by Environmental Health.

**Overall Inspection Comments**

Upon inspection, it was observed that all main drains in both the pool and spa were visible and both bodies of water appeared well maintained.

The restroom in question is an auxillary restroom just off the deck of the pool. Management has closed this restroom for repairs and is in the process of deciding what they want to do with it. At this time, it is being maintained clean with all water turned off. This restroom may be removed and converted into a storage room according to management. There are both men's and women's locker rooms nearby with multiple restroom amenities available within 300 feet.
