POINTS 2	Compliance date not specified	Inspector Comments: - At the beginning of inspection measured hot water from premix faucets in women and men restrooms at max 87 F. The water temperature quickly went down to 79 F. - The hot water at kitchen hand sink did not come out on timely manner. The inspector had to open the faucet for more than 4 minutes to get the hot water. Provide constant water temperature at 100 - 108 F to premix faucets and at min. 100 F to the faucet in the kitchen in timely manner.

POINTS 1	Compliance date not specified	Inspector Comments: Observed creamer nozzle not properly cut. Ensure that this nozzle is cut in angle. Please read manufacturer's specification written on the inside of the machine. Observed raw shelled eggs stored above frappe mix and cheese in walk-in cooler. Store raw animal products below ready to eat foods. Corrected on site.

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.

Ensure to keep all equipments clean and in good repair. Observed mold accumulation inside ice machine and on tray of drinking fountain at drive thru. Maintain clean.

All utensils and equipment shall be approved, installed properly, and meet applicable standards. 40. WIPING CLOTHS: PROPERLY USED AND STORED

POINTS 1	Compliance date not specified	Inspector Comments: Observed several wet wiping cloths on counters. Store them in sanitizer bucket between each use. Corrected on site.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

POINTS 1	Compliance date not specified	Inspector Comments: Observed the pipe under ice bin in drive thru disconnected. Observed melted ice dripping into the floor. Ensure that the wastewater drains into the floor sink. Corrected on site.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

42. GARBAGE AND REFUSE PROPERLY DISPOSED; FACILITIES MAINTAINED

POINTS 1	Compliance date not specified	Inspector Comments: Observed some food waste and debris on floor of dumpster area. Ensure that dumpster area is kept clean and free of debris to prevent vermin harborage.

Violation Description: All food waste and rubbish shall be kept in leak proof and rodent proof containers. Containers shall be covered at all times. All waste must be removed and disposed of as frequently as necessary to prevent a nuisance. The exterior premises of each food facility shall be kept clean and free of litter and rubbish. (114244, 114245, 114245.1, 114245.2, 114245.3, 114245.4, 114245.5, 114245.6, 114245.7, 114245.8)

45. FLOORS, WALLS AND CEILINGS: BUILT, MAINTAINED, AND CLEAN

POINTS 1	Compliance date not specified	Inspector Comments: Observed grime and debris build-up on floors under ice bin at drive thru and under the fryer. Observed deep lines and standing water in between the tiles in dish washing area and coffee station. Ensure that all floors are smooth and easily cleanable. Maintain the floors clean.
	Not In Compliance	

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
