POINTS 2	Compliance date not specified	Inspector Comments: Observed lack of knowledge regarding : -Drying the thermometer sitting in cup with sanitizer water . Employee stated she picks the thermometer from the sanitizer cup ,rinse it with water and them use it. Employee need to let it air dry after sanitizing or can dry using a disposable paper towel to dry before each use. -How to use the 2 compartment sink properly . Employee stated they rinse the utensils , wash them , then sanitize them without rinsing the soap first . Explained the proper steps with employee and manager in charge. Repeated Violation. It is highly recommended to replace the 2 compartment sink with a 3 compartment sink to avoid future repeated violation.

	Not In Compliance Violation Reference - HSC - 114149, 114149.1	

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)
