Maintain food in cold holding at 41F and below. Per operator the tomatoes had been placed in cold holding approximately an hour prior. Suggested to use metal/aluminum containers to hold items in cold holding to maintain temperature at 41F and below.

POINTS 1	Compliance date not specified	Inspector Comments: Observed wet wiping cloth on counter. Store wet wiping cloths in sanitizer bucket when not in use.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
