Inspector Comments: Observed "B" letter grade removed from original location. Letter grade was moved to a window that is heavily tented and prevents easy viewing for public. Ensure to not remove letter grade from original location. Ensure letter grade is stored in a conspicuous location. Letter grade re-posted in original location. Do not move, relocate, or remove grade card. Failure to comply will result in a charged inspection at an hourly rate of \$245.

Violation Description: Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location. (114381(e)) Letter Grade Placecard shall be properly posted. SBCC 33.1406
