Inspector Comments: Upon arrival to drop off the official inspection report, observed the letter "B" grade recently posted by the Environmental Health Specialist had been relocated to another location. Discontinue this practice immediately.

Letter "B" grade was reposted by the Environmental Health Specialist. Do not remove/hide/replace letter grade posted by the Environmental Health Specialist. Failure to do so will result in further CHARGED re-inspection and/or fees assessed.

Violation Description: Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location. (114381(e)) Letter Grade Placecard shall be properly posted. SBCC 33.1406
