**Violation Description:** Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

**Overall Inspection Comments**

"A" grade posted.

**NOTE:**

-Observed facility leaving cold pasteurized eggs at room temperature. Per operator, eggs are left at room temperature for about 20 to 30 minutes to cool to avoid coagulation during preparation and cooking. Ensure all potentially hazardous foods are held at 41°F or below for proper cold-holding OR keep all potentially hazardous foods under time control and discard every four hours after leaving out at room temperature.
