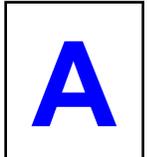

Inspector Comments: Ensure to provide a minimum hot water supply to properly wash utensils in automatic warewash machine of 120 degrees, and 100 degrees at handwash and prep sink.

Observed no warm water supply at automatic warewash machine, and prep sink.

Discontinue use until hot water as been restored to automatic warewash machine and handwash sink. Hot water available at 3 compartment sink, pre rinse sprayer, and handwash sink. Manually warewash until repaired. Facilities Maintenance on site and repairing at time of inspection.
 Observed hot water slowing rising.

Facility is using disposable utensils until repaired. Ensure to clean and sanitize prep sink prior to reuse.

Violation Description: An adequate, protected, pressurized, potable supply of hot water and cold water shall be provided at all times. (113953(c), 114099.2(b) 114101(a), 114189, 114192, 114192.1, 114195)

34. WAREWASHING FACILITIES: INSTALLED, MAINTAINED, USED; TEST STRIPS

Inspector Comments: Ensure automatic warewash machine is in proper working condition.

Observed no hot water available. Ensure a minimum hot water supply of 120 degrees as recommended on machine data plate.

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

Observed food debris on bottom of plastic containers where clean and sanitized utensils are stored.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)
