POINTS 4	Compliance date not specified	Inspector Comments: Observed employee placing on gloves , crack eggs , remove the gloves and proceed to handle the spatula and handle ready to eat food without proper hand washing. . Observed another employee placing on gloves , reach for raw burger patties , place on the grill , take gloves off then handle other ready to eat food without proper hand washing. Employee must wash their hands properly between handling raw eggs/ meat and handling ready to eat food. Repeated Violation . Manager addressed the violation with the cooks and they started to wash their hands properly in between handling raw food and ready to eat food.
	Complied on 11/21/2013	

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
