Inspector Comments: Observed filet's of fish at 58F. Employee stated the fish had been placed in cold holding for lunch service at 11AM till 2PM. The fish was observed on a table out of cold holding at 4PM. employee voluntarily discard the fish for safety reasons.

Observed cheese and potatoes on the steam table at 116F. Cook stated it was cooked in the oven 2 hours prior. Employee was asked to reheat the item to over 165F and did so immediately.

Ensure potentially hazardous foods are held at or below 41F or at or above 135F.

See item # 52 regarding the fish.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Inspector Comments: Observed employee wipe food debris from a shelf into a container of gravy. Once it was brought to his attention he voluntarily discarded the gravy. See item # 52. Maintain food free of adulteration or contamination.

Recommendation: Use lids on containers to prevent contamination.

Violation Description: All food shall be manufactured, produces, prepared, compounded, packed, transported, kept for sale, and served so as to be pure and free from adulteration and spoilage. Any food is adulterated if it bears or contains any poisonous or deleterious substance that may render it impure or injurious to health. (113967, 113976, 113980, 113988, 113990, 114035, 114254(c), 114254.3)

40. WIPING CLOTHS: PROPERLY USED AND STORED

Inspector Comments: Observed wet sanitizer towels out of their sanitizer bucket. Store all wet or repeatedly used towels in a sanitizer solution or discard to laundry. Ensure sanitizer levels are maintained between 100ppm and 200ppm (chlorine) or between 200ppm and 300ppm (quaternary ammonia).

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
