7. PROPER HOT AND COLD HOLDING TEMPERATURES

POINTS 2	Compliance date not specified	Inspector Comments: -Observed a container of sliced American cheese held at room temperature at prep's area. Measured temperature at 66°F. Per operator, American cheeses have been left out at room temperature since 11:00am and are transferred from walk-in cooler to thaw at room temperature for one hour, then transferred onto cold-holding unit at cook's line for use for seven hours and discarded, thereafter. Ensure all potentially hazardous foods are held at 41°F or below for proper cold-holding. NOTE: -Facility does not have a variance available at facility for American Cheese. -Facility will submit variance to Division of Environmental Health Services (DEHS) in San Bernardino County. -Facility will keep American cheese at 41°F and discontinue practice of leaving cheese out at room temperature for one hour, until a variance is submitted and approved by DEHS or the State of California. Corrective action at time of inspection: -Operator discarded container with three stacks of American Cheese. See VC&D.
