Employee stated the bowls begin to be used at about 12 noon and remain there until the end of the day when they are washed. Ensure all utensils not in temperature control are washed at minimum of every 4 hours. Employee was asked to wash the bowls and did so immediately.

Employee stated it was placed in the table 1 hour prior. Ensure potentially hazardous foods being kept cold are maintained at or below 41F. To maintain temperature use deeper containers, do not over fill the container, and the use of heat conducting materials such as metal will aid in keeping the temperature as low as possible.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

38. ADEQUATE VENTILATION AND LIGHTING; DESIGNATED AREA

POINTS 1	Compliance date not specified	Inspector Comments: Observed two lights and one shatter guard missing under the hood. Ensure lights are replaced and shatter guards are installed.

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)

POINTS 1	Compliance date not specified	Inspector Comments: Observed rear door open during inspection. Door does not self close or self latch. Ensure rear door stays closed when not receiving deliveries.

Observed hole in the wall where a plumbing the hole is located near the toaster oven. Observed missing ceiling tiles above the reach in refrigerator. Repair hole and replace ceiling tiles.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)
