**Inspector Comments:** During the routine inspection on 01-13-2014, observed 1 employee missing a food worker card. Facility was given 14 days (until 01-27-2014) to fax in missing food worker card information to the Division of Environmental Health Services (DEHS). DEHS has not received proof of 100% compliance with county food worker card requirements.

During the billable re-inspection on 02-03-2014, observed the missing food worker card.

Facility has now met compliance with county food worker card requirements. No further action in this area is required.

**Violation Description:** During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.
