**Inspector Comments:** During the routine inspection on 01-16-2014, observed 4 employees missing food worker cards. Facility was given 14 days (until 01-30-2014) to fax in missing food worker card information to the Division of Environmental Health Services (DEHS). DEHS has not received proof of 100% compliance with county food worker card requirements. [Note: DEHS had received San Bernardino County food worker card information for three (3) of the four (4) employees, but not for the fourth employee. The card number for the fourth employee could not be found in the computer system.]

During the billable re-inspection on 02-03-2014, observed food worker information for the fourth employee (it was a ServSafe food safety manager's certificate).

Facility is now in compliance with county food worker card requirements. No further action in this area is required.

**Violation Description:** During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.

**Overall Inspection Comments**

Facility is now in compliance with county food worker card requirements. No further action in this area is required.
