**Inspector Comments:** During the last routine inspection the facility was out of compliance with four missing/expired food worker cards.

During the follow-up inspection the facility was able to provide proof for three food worker cards. Person in charge stated that the fourth employee was no longer working at the facility. Observed that said employee is not on the current work schedule. The facility has been cleared in the field by the inspector and is now in 100% compliance with food worker cards.

**Violation Description:** During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.
