9. PROPER COOLING METHODS

Inspector Comments:

-Observed a tray of shredded chicken and shredded beef held in walk-in cooler at 44°F - 46°F. Per operator, foods have been cooked, then cooled in walk-in cooler a couple of days ago. Ensure all potentially hazardous foods are cooled rapidly from 135°F to 70°F, within 2 hours, and then from 70°F to 41°F, within 4 hours. Cooling shall be done by one or more of the following methods: shallow containers, ice bath, or separating food into smaller portions and cooled in refrigerator. See VC&D.

Corrective action:

-Operator removed two (2) trays of shredded chicken and shredded beef from walk-in cooler and not to be used due to improper cooling.

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

-Observed three (3) half cut tomatoes held at 62°F at room temperature at cook's line. Per operator, tomatoes were just cut during an order.

-Observed three (3) separate trays with ground pork, ground beef, and chicken held at 44°F - 45°F in pull-out drawer at cook's line.

Ensure all potentially hazardous foods are held at 41°F or below at all times for proper cold-holding.

NOTE:

-Observed torn and loose gaskets on pull-out drawers. Repair/replace gaskets to ensure pull-out drawer closes properly for proper cold-holding of foods at 41°F or below.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Ensure all in-use wiping towels are returned to sanitizer bucket after every use. -Observed quat sanitizer level below 200 ppm in sanitizer bucket and three compartment sink (with a washed item). Ensure sanitizer level is maintained between 200 ppm - 300 ppm for quat.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
