<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed soda gun nozzle and holder at bar with soda debris build up.  Ensure that soda gun is cleaned daily: washed, rinsed and sanitized.

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed can of Raid pesticide stored on same counter as clean silver ware.  Raid is not a commercial pesticide and is prohibited in a commercial food facility. Remove Raid from food facility.

**Violation Description:** All poisonous substances, detergents, bleaches, and cleaning compounds shall be stored separate from food, utensils, packing material and food-contact surfaces. (114254, 114254.1, 114254.2) An insecticide, rodenticide, or other pesticide must be used in accordance with the manufacturer's instructions.

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed floor nearby and sides of equipment with dried food debris and grease.  Clean and maintain.

**Violation Description:** All nonfood contact surfaces of utensils and equipment shall be clean. (114115 (c))

**34. WAREWASHING FACILITIES: INSTALLED, MAINTAINED, USED; TEST STRIPS**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed quat test strips being used for chlorine (bleach) sanitizer at bar.  Ensure to use the proper test strips with specified sanitizer. For chlorine sanitizer, use chlorine test strips and maintain sanitizer at 100-200ppm. Provide proper test strips immediately. Test strips available at restaurant depot.

**Violation Description:** Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed ice scoop stored directly on top of ice machine in kitchen.  Ensure to store ice scoop in a sanitary manner, such as in an easily cleanable container. Ice scoop and container must be cleaned DAILY.

**Violation Description:** All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

**38. ADEQUATE VENTILATION AND LIGHTING; DESIGNATED AREA**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed hood filters with excessive grease and dust build up.  Clean and maintain. Minimum cleaning should be monthly.

**Violation Description:** Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)

**39. THERMOMETERS PROVIDED AND ACCURATE**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed only a meat thermometer available for probe thermometer, measuring from 130-190 F.  Provide an accurate thermometer that measures a full range of food temperatures, from approximately 0-220 F.
	Not In Compliance	

**Violation Description:** An accurate easily readable metal probe thermometer suitable for measuring temperature of food shall be available to the food handler. A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)

Provide proper test strips and thermometer as soon as possible.

Observed a few ants on floor near plastic rolling cabinet in kitchen. Seal any cracks to prevent vermin entry. Eliminate any vermin presence from perimeter of facility. Observed no other pest presence inside of facility.
