Inspector Comments: Observed cook with two pairs of gloves on at cook's line. Cook would put on second pair of gloves when handling raw hamburger patty and then remove the second pair of gloves after placing patties on the grill. Ensure employees are aware that double gloving is NOT allowed. Discontinue double glove practice.

Observed employee, with gloved hands, wash hands and gloves at hand sink then proceeded back to cook's line to handle food items. Gloves are to be used one time only. Washing of hand gloves is not allowed.

Ensure all employees wash hands thoroughly before wearing gloves, in between glove changes, in between change of task, after touching any part of body/clothing and after using the restroom.

Corrected on site.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

Inspector Comments: When asked, cook was not aware of the minimum cooking temperature for a hamburger patty. Ensure all staff is knowledgeable regarding their assigned duties. Ensure cook is knowledgeable regarding minimum cooking temperatures to prevent food borne illness from occurring.

Cooking temperature stickers provided.

Violation Description: All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

Inspector Comments: Observed Quat sanitizer at 100 ppm at cook's line. Use test strips and ensure Quat sanitizer is maintained between 200-400 ppm for proper sanitizing.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
