**14. FOOD CONTACT SURFACES: CLEAN AND SANITIZED** **⚠ CRITICAL ⚠**

**Inspector Comments:** Observed employee actively washing utensils improperly. Facility has a dishwashing machine, however, it is not used by the employees. Facility is using the 2-compartment sink to wash all utensils.

Because the facility uses a 2-compartment sink, it shall use the batch washing process and do the following: Prepare 1st compartment with soap and warm water (100 F minimum), rinse on 2nd compartment and then go back to the 3rd compartment and fill with water and sanitizer to properly disinfect utensils.

Facility is now using separate containers in lieu of the approved compartments of utensil sink. Refrain from this practice, as it is unapproved. Also, observed employee mixing soap, water and sanitizer on the same container in order to wash and then rinse the utensils. Approved method is to wash, rinse and then sanitize.

**Violation Description:** All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

**1. DEMONSTRATION OF KNOWLEDGE; FOOD SAFETY CERTIFICATION**

**Inspector Comments:** Employees were unaware of proper holding temperatures and proper warewashing steps. Ensure that employees are aware of approved hot holding (135 F or above) and cold holding (41 F or less) temperatures. Additionally, ensure that employees wash utensils properly by washing, rinsing, sanitizing and air drying.

**Violation Description:** All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

**6. ADEQUATE HANDWASHING FACILITIES SUPPLIED & ACCESSIBLE**

**Inspector Comments:** Observed no soap in the handwash sink (handwash sink is shared with 2-compartment utensil sink). Ensure that handwash sink is adequately stocked at all times. Observed sanitizer in the dispenser instead of soap at time of inspection.

**Violation Description:** Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

**23. NO RODENTS, INSECTS, BIRDS, OR ANIMALS**

**Inspector Comments:** Observed dead roaches on the floor in the back storage areas of the facility. Clean/maintain floor from dead roaches. Maintain facility to prevent accumulation of dead roaches.

**Violation Description:** Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

**34. WAREWASHING FACILITIES: INSTALLED, MAINTAINED, USED; TEST STRIPS**

**Inspector Comments:** Observed missing chlorine test strips to adequately monitor sanitizer concentrations. Maintain at 100 ppm when disinfecting counters and utensils.

Observed only Ammonia Quat sanitizer test strips at time of inspection, however, facility is not using Ammonia to disinfect.

**Violation Description:** Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

Observed excess water accumulation inside beer refrigerators in the bar. Clean/maintain inside refrigerator.

Observed excess water/dust accumulation inside ice scoop container. Clean/maintain container and ice scoop at all times.

Observed grime build-up on the soda gun and soda gun holster of the bar area. Clean/maintain equipment properly and sanitize adequately.

**Violation Description:** All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. (114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114177, 114180, 114182)

**39. THERMOMETERS PROVIDED AND ACCURATE**

**Inspector Comments:** Provide a thermometer inside the reach-in refrigerator in the kitchen to adequately monitor food temperatures. Observed missing.

Provide approved probe thermometer to adequately monitor food temperatures of cooked food items. Observed no probe thermometer in the facility.

**Violation Description:** An accurate easily readable metal probe thermometer suitable for measuring temperature of food shall be available to the food handler. A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)

**41. PLUMBING; PROPER BACKFLOW DEVICES**

**Inspector Comments:** Observed leak on faucet of 2-compartment sink. Repair leak on faucet to prevent further leakage.

**Violation Description:** The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

**44. PREMISES; PERSONAL/CLEANING ITEMS; VERMIN-PROOFING**

**Inspector Comments:** Observed unchained CO2 tanks in the bar area. Ensure that CO2 tanks are properly chained to prevent from tipping over and potential explosion since these are pressurized containers.

Observed front door wide open at time of inspection. Maintain door closed to prevent potential vermin intrusion into the facility.

**Violation Description:** The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

**45. FLOORS, WALLS AND CEILING: BUILT, MAINTAINED, AND CLEAN**

**Inspector Comments:** Clean/maintain floor sink in the bar area to prevent potential clogging. Observed grime and a plastic bag inside floor sink at time of inspection.

**Violation Description:** The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
