<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed raw shells eggs on ice measuring 52F, and pooled eggs measuring 45F. Maintain food raw eggs at 45F and pooled eggs at 41F and below.

**Violation Description:** Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed CO2 canisters not fastened to a rigid structure. Fasten CO2 canisters to a rigid structure.  Observed scoop stored inside of container of flour with handle touching food product. Store scoop in a way so that the handle does not touch the food product.  Observed containers without handles being used as scoop inside of bulk containers. Provide scoops with a handle.

**Violation Description:** All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

**40. WIPING CLOTHS: PROPERLY USED AND STORED**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed sanitizer (behind front counter) measuring less than 100ppm. Maintain sanitizer at 100ppm-200ppm.

**Violation Description:** Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

**48. FOOD WORKER CERTIFICATION**

<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed 1 invalid food worker card. Provide valid County of San Bernardino food worker card within 14 days (4/28/14). Failure to comply will result in a charged re-inspection.
