Inspector Comments: Observed utensils inside of sanitizer in three compartment sink with quaternary ammonia measuring 100ppm. Ensure that utensils are sanitizer in quaternary ammonia measuring at least 200ppm. Ensure that all food contact surfaces are properly cleaned and sanitized.

Observed employee go to three compartment sink and wash a utensil, rinse it off, and then handle food with it without first sanitizing the utensil. Ensure that all food contact surfaces are cleaned and sanitized.

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

Inspector Comments: Observed cook unable to provide proper knowledge on cooking temperatures of chicken and fish. Ensure that employees are knowledgeable about their duties.

Violation Description: All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

30. FOOD STORAGE; FOOD STORAGE CONTAINERS IDENTIFIED

Inspector Comments: Observed containers of flour and sugar in storage without any labels. Provide labels on foods that look similar.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

36. EQUIPMENT, UTENSILS AND LINENS: STORAGE AND USE

Inspector Comments: Observed plates/bowls in storage containing food debris. Store utensils in a way to protect clean utensils in storage.

Observed scoops in food containers with the handle touching the food. Store scoops in a way so that the handle does not touch the food.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

40. WIPING CLOTHS: PROPERLY USED AND STORED

Inspector Comments: Observed wet wiping cloths stored in sanitizer buckets with quaternary ammonia measuring 100ppm. Maintain sanitizer at a minimum of 200ppm.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
