7. PROPER HOT AND COLD HOLDING TEMPERATURES

Inspector Comments: Observed the following cold holding violations:
 1) Raw chicken holding between 47F and 52F in the upper portion of the reach-in prep refrigerator (across from the fryers). Took multiple temperatures, measuring 47F, 48F, 49F, 50F, 51F, and 52F). The operator voluntarily discarded pieces of chicken that were holding at 50F or above. See VC&D.
 2) Cooked pasta holding between 49F and 50F in the lower portion of the reach-in prep refrigerator (across from the fryers).

Maintain food in cold holding at 41F or below.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Inspector Comments: Observed an employee conducting active mechanical warewashing. Observed chlorine sanitizer level at zero (0) ppm.

Ensure that chlorine sanitizer level is 50 ppm when conducting mechanical warewashing.

Note: manager telephoned maintenance repair person to come fix the machine. Facility is using 3-compartment sink to conduct manual warewashing until the dish machine is repaired.

Ensure that mechanical dish machine is fully functional within 48 hours. Inspector will conduct a re-inspection to determine compliance.

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

Inspector Comments: Observed bags of flour stored on the floor, near the dough station. Observed boxes of soda stored on the floor in the back storage area (near the warewashing area).

Ensure to store all food items at least 6 inches off the floor, to protect from splash, dust, vermin, or other forms of contamination or adulteration.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

Inspector Comments: Observed a large amount of food debris, dust, and decaying food on the shelf in the lower portion of the reach-in prep refrigerator (across from the fryers).

Remove food debris, dust, and decaying food. Clean thoroughly and regularly, and maintain free of debris.

Observed dust build-up on the fan guards in the upright reach-in freezers.

Clean thoroughly and regularly, and maintain free of dust build-up.

Observed dust and debris build-up on the seals/gaskets of the small ice cream display freezer.

Clean thoroughly and maintain free of excess dust and debris build-up.

Violation Description: All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. (114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114177, 114180, 114182)

48. FOOD WORKER CERTIFICATION

Inspector Comments: Observed 3 employees without current, valid San Bernardino County food worker cards. Ensure that employees maintain current, valid San Bernardino County food worker cards.

Employees must provide current food worker card within 14 days. There will be a re-inspection charge of \$245.00 per hour if current food worker card information is not faxed to the Division of Environmental Health Services at 909-387-4272 on or before 05-08-2014.

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
