(113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

POINTS 1	Compliance date not specified	Inspector Comments: Improper scoop observed in the container of sugar. Provide a scoop with a handle. Open container of cooked tomatoes observed stored next to sanitizer bucket on the 3-compartment sink. Separate food from sanitizer to protect from potential contamination.

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.

POINTS 1	Compliance date not specified	Inspector Comments: Debris/mold/grime buildup observed inside of the ice machine. Clean and sanitize the machine. Maintain equipment in good condition. Replace if needed. Heavy ice buildup observe in the reach-in freezer located in the back storage area. Clean and maintain the freezer in good condition.

POINTS 1	Compliance date not specified	Inspector Comments: Inoperable light observed over the food prep area. Repair/Replace the light bulb.

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)
