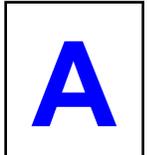

POINTS 4	Compliance date not specified	Inspector Comments: Observed chopped chicken and beef at 125F in the front assembly line. Ensure all potentially hazardous food items are maintained at or below 41F or at or above 135F. Items that were out of temperature were put out 10 minutes prior to the temperature reading and will be used within minutes due to the pace of business, so items were allowed to remain in the steam table for customer service. Observe low water level / water not touching the bottom of the pans. Recommend more water or deeper pans.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

POINTS 2	Compliance date not specified	Inspector Comments: Observed 2 missing food workers cards. Ensure all food workers have a valid San Bernardino County food workers card. Food worker's card form left with person in charge. This form must be filled out with the birth date, valid San Bernardino County food workers card number, and faxed to (909) 387-4272 prior to 14 days from the date of this inspection. If not received there will be a charged inspection at the cost of \$245.00 per hour to follow up on the missing cards. Observed several employees on the schedule that do not have the food worker's card but have been working less than 2 weeks. Note: Employees must be certified no later than 14 days from their start date. See form left with manager for website to obtain the correct card as only San Bernardino Food Worker Cards are accepted.

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
