<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed no paper towels in the dispenser by the handwashing sinks in the kitchen and in the male restroom. Observed non functioning paper towel dispenser in the female restroom. Provide repairs and ensure that the handwashing sinks are adequately supplied at all times. Corrected during inspection.

**Violation Description:** Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

**14. FOOD CONTACT SURFACES: CLEAN AND SANITIZED**

<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed the quaternary ammonia sanitizing solution in bucket at less than 200ppm. Ensure that quaternary ammonia sanitizing solutions are maintained at 200ppm. Store wiping cloths in sanitizing solution in buckets prior to and after each use. Corrected during inspection.

**40. WIPING CLOTHS: PROPERLY USED AND STORED**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed wet wiping cloths on counter tops. Place wiping cloths in sanitizing solution prior to and after each use, or store in other approved storage immediately after each use.

**Violation Description:** Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
