Ensure that the facility obtains approved pest control service and eliminates pests from the facility. Contact Health Department when ready (800) 442-2283. Facility shall remain closed for a minimum of 24 hours before permit is re-instated. Facility shall contact health department prior to opening because approval from health department is required.

Ensure that all potentially hazardous foods are kept at 41 F or less at all times. Pizza toppings had been placed on table an hour ago and where placed back into the walk-in refrigerator to bring down to 41 F or less.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

POINTS 4	Compliance date not specified	Inspector Comments: Observed live roaches in the warewashing area of the facility. Roaches had accumulated behind the broken cove base and was shown to employees in the facility. Additionally, observed live roach near pizza oven. Ensure that pest control services are contacted immediately to eliminate pest infestation. Ensure that all cracks, holes, gaps and crevices are sealed properly to prevent further intrusion into the facility. This is the second time this facility is closed for roaches within a period of 1 year. Continue working with pest control in order to completely eliminate roaches. Ensure that entire facility is cleaned/sanitized properly. All counters and equipment shall be cleaned/sanitized.

POINTS 1	Compliance date not specified	Inspector Comments: Observed no chlorine test strips to monitor sanitizer concentration. Provide test strips to adequately monitor chlorine levels at 100 ppm. Ensure that facility prepares sanitizer buckets in the prep area to adequately clean counters during hours of operation and replace sanitizer once every 4 hours or whenever necessary.

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

POINTS 1	Compliance date not specified	Inspector Comments: Seal all gaps, holes and crevices to eliminate pest intrusion. Observed cracks on wall and cove base tiles where roaches hide.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. POINTS 2	Compliance date not specified	Inspector Comments: Observed missing food handler cards. Provide missing food handler cards to our office within 14 days. Failure to do so will result in further re-inspections charged at \$122.50 per 30 minutes. Obtain valid San Bernardino County food handler cards.

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
