Inspector Comments: Observed debris buildup on cabinets behind the front counter. Observed that some cabinets were damaged. Clean and repaint.

Observed grease buildup on the hood over the charbroiler. Clean and maintain.

Violation Description: All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. Inspector Comments: Observed that the sanitizer solution in the buckets was dirty. Change the sanitizer solution often.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
