POINTS 2	Compliance date not specified	Inspector Comments: Ensure employees are aware of assigned duties. Observed employee not aware of cooking temperature of chicken and cooling process. Left cooking temperature sticker. <u>Rapidly cool potentially hazardous food from 135F to 70F within 2 hours and from 70F-41F within 4 hours.</u>

Violation Description: All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. POINTS 2	Compliance date not specified	Inspector Comments: Provide paper towels in the hand washing sink by ice cream station. Observed none. <u>Corrected on site. Operator provided paper towels in dispenser.</u>

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

7. PROPER HOT AND COLD HOLDING TEMPERATURES

POINTS 2	Compliance date not specified	Inspector Comments: Maintain potentially hazardous food at 41F or below. Observed sour cream with internal temperature 48F , raw meat at 49F, and cheese at 49F in walk in cooler. Observed walk in cooler thermometer read 55F and surface temperature of 52F. Operator moved raw beef meat into freezer and has two prep table refrigerators to store sour cream and cheese at 41F. Immediately repair/replace walk in cooler to hold 41F. Will reinspect within one day. Operator states walk in cooler was serviced at noon. Maintain potentially hazardous food at 135F or above. <u>Observed beef taquitos with internal temperature of 108F sitting out on prep-fridge table.</u>

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.
