(113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

(114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
