Also observed ambient temperature of the same unit measuring at 56 deg F. Check unit and repair/replace, and ensure all refrigerated potentially hazardous foods are kept at 41 deg F or below. (all food in unit that was defrosting removed to another refrigerator).

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
