Inspector Comments: During the routine inspection on 08-19-14, facility scored a "C" letter grade (score of 76). Facilities that score a "C" are required to submit a request for re-score within 30 days. Form was left with facility to submit within the 30 days.

As of 9-23-14, the Division of Environmental Health Services has not received a request for re-score. (Inspector has tried multiple times to reach facility via telephone and email.)

During the re-inspection on 09-23-14, operator stated that she thought she could submit the form whenever she wanted to. [Form clearly states that the written request for a re-score must be submitted within 30 days.] Operator filled out form and gave it to inspector.

Also during the re-inspection on 09-23-14, observed that the letter grade had been moved from where inspector posted it. Spoke to manager and informed her that C letter grade cannot be moved, relocated, or removed. Operator stated that she thought she could move the grade. [Grade card states that it shall not be tampered with or removed.] Reminded operator that inspector had written in the report that grade card cannot be moved, removed, obscured, covered up, etc. Re-posted letter grade.

Do not move, relocate, or remove grade card. Do not cover up or obscure grade card. Failure to comply will result in a charged inspection at an hourly rate of \$245.

Violation Description: Reinspection conducted at this time to determine compliance from prior inspection.
