POINTS 1	Compliance date not specified	Inspector Comments: Observed raw shell eggs stored directly over cheese and half & half creamer in reach-in refrigerator in kitchen. Ensure that food is stored in such a way that it prevents the possibility of cross contamination. *Recommended to store raw shell eggs and raw poultry toward the bottom shelf of refrigeration.

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.

30. FOOD STORAGE; FOOD STORAGE CONTAINERS IDENTIFIED

POINTS 1	Compliance date not specified	Inspector Comments: Observed multiple food containers storing sugar, cranberries, etc without proper labels. Observed opened bag of chips stored on prep table. Ensure that all bulk foods, or foods in non-resealable packaging, are transferred into an approved container with a tightly fitting lid and a label after opening.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

40. WIPING CLOTHS: PROPERLY USED AND STORED

POINTS 1	Compliance date not specified	Inspector Comments: Observed 3 wet wiping cloths stored on counter at espresso machine in serving area. Ensure that all wet wiping clothes are stored in a sanitizer bucket with appropriate concentration of sanitizer when not in immediate use.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
