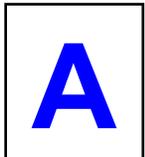

7. PROPER HOT AND COLD HOLDING TEMPERATURES

Inspector Comments: Multiple PHFs (i.e., two or more food items in separate containers/ or compartments), are found held at temperatures of 50°F to 130°F without any other approved intervention. Pans filled with perishable foods stored in steam table were not in contact with hot water to conduct heat to pans. Deeper pans were filled with water and then shallow pans placed into it where contact with hot water keeps foods hot.

Precooked battered chicken must be kept hot or cold. Deep white plastic container was observed with once cooked chicken at 70°F. This was placed under refrigeration.

Colander of cooked rice was observed at 100°F. Approximately one quart was discarded.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

6. ADEQUATE HANDWASHING FACILITIES SUPPLIED & ACCESSIBLE

Inspector Comments: Obstructed, inaccessible, improper use of, or unclean handwashing sink. Multiple items stored in hand wash sink. Maintain hand wash sink accessible for immediate use.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

14. FOOD CONTACT SURFACES: CLEAN AND SANITIZED

Inspector Comments: Equipment and utensils are not allowed to adequately drain or air dry before reuse.

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

40. WIPING CLOTHS: PROPERLY USED AND STORED

Inspector Comments: Wet wiping cloths and dry wiping cloths, are not free of food debris and visible soil. Working containers of sanitizing solutions for storage of in-use wiping cloths are not used in a manner that prevents contamination of food, equipment, utensils, linens, or single-use articles. Place wiping cloths into sanitized solution prior to and after each use.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

41. PLUMBING; PROPER BACKFLOW DEVICES

Inspector Comments: Add water to exposed drain lines to prevent sewer gas from entering facility.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)
