Inspector Comments: Measured shredded cheese and sour cream holding between 45-46 F on the top cold pan of the reach in cooler . Potentially hazardous food must be held @ 41 F and below. Cheese and sour cream transferred to the 2 door stand up cooler during inspection.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

26. APPROVED THAWING METHODS USED, FROZEN FOOD

Inspector Comments: Observed thawing a package of avocado in the food prep sink at room temperature . Thawing shall be under running water or in the cooler.

Violation Description: Food shall be thawed under refrigeration; completely submerged under cold running water (less than 70F) of sufficient velocity to flush loose particles for less than 2 hours; in microwave oven; or during the cooking process. (114018, 114020, 114020.1)

Inspector Comments: Observed the fly fans on both of the back door and the drive thru window turned off while the door and window wide open. Keep fly fans turned on to prevent fly (one fly) intrusion as observed during inspection .

Observed personal food on the dry storage shelves in the back . Store all personal food in a designated area to prevent possible contamination.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)
