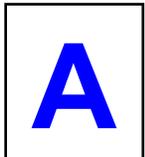

9. PROPER COOLING METHODS

Inspector Comments:

Rapidly cool potentially hazardous foods from 135F to 70F within two hours and then to 41F or below within the next four hours using an approved method of cooling.

Approved methods include:

- Placing food into shallow metal pans
- Separating foods into smaller portions,
- Adding ice as an ingredient,
- Using ice paddles,
- Using an ice bath,
- In accordance to an approved HACCP or variance,
- Or other methods approved by enforcing agency.

Observed hash browns in temperature range being cooled in walk-in in deep cartons. The cartons may not help facilitate heat transfer to enable rapid cooling.

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

40. WIPING CLOTHS: PROPERLY USED AND STORED

Inspector Comments:

Store wiping cloths in an approved sanitizer solution between 200 and 400 ppm when using quaternary ammonia.

Observed wet wiping cloth stored on dry rack in ware wash area.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
