9. PROPER COOLING METHODS

POINTS 2	Compliance date not specified	Inspector Comments: Observed pans of cooked rice cooling at 100F near the food prep table by the back door. Properly cool all previously cooked food from 135F to 70F within 2 hours and from 70 to 41F within 4 hours. Operator immediately placed the rice under refrigeration.
	Not In Compliance	

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

34. WAREWASHING FACILITIES: INSTALLED, MAINTAINED, USED; TEST STRIPS

POINTS 1	Compliance date not specified	Inspector Comments: Dishwashing machine failed to dispense sanitizer and failed to reach a temperature of 160F. Repair the dishwasher to ensure sanitizing is achieved. Utilize the 2 compartment sink until the machine is verified to be working properly.
	Not In Compliance	

Missing drain plugs. Obtain approved drain plugs so that utensils may be washed properly in the 2 compartment sink.

Note: the machine was not actively in use during the inspection

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

POINTS 1	Compliance date not specified	Inspector Comments: Observed duct tape on the ice machine. Remove the tape and properly repair the machine.

Violation Description: All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. (114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114177, 114180, 114182)

40. WIPING CLOTHS: PROPERLY USED AND STORED

POINTS 1	Compliance date not specified	Inspector Comments: Observed wiping cloths stored in 50ppm chlorine. Store all wet wiping cloths in 100ppm-200ppm chlorine.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
