<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed empty paper towel dispenser at sink in kitchen and in restroom. Ensure all hand washing supplies are kept stocked in their dispensers for proper hand washing.

**Violation Description:** Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

**7. PROPER HOT AND COLD HOLDING TEMPERATURES**

<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed carton of shelled eggs on counter in kitchen at 66F. Observed container of dairy creamer at 78F on front counter. Operator states eggs and creamer have been out on counter for about 15 minutes. Ensure all potentially hazardous foods are held at or below 41F for proper cold holding.

Corrected on site, employee placed eggs and creamer in reach in cooler.

**Violation Description:** Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed missing chlorine sanitizer test strips. Provide chlorine test strips and ensure chlorine sanitizer is maintained between 100-200 ppm for proper sanitizing.

**Violation Description:** Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.
