(113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Observed employee actively wiping down food contact surfaces with a sanitizer wiping towel stored in front prep sink. Observed sanitizer concentration of wiping towel and sanitizer bucket at 0ppm. Corrected on site. Ensure food contact surfaces are cleaned and sanitized properly. Ensure sanitizer concentration (chlorine) is 100ppm. Ensure sanitizer solution is monitored with test strips daily.
