POINTS 4	Compliance date not specified	Inspector Comments: Maintain potentially hazardous food in cold holding at 41F or below and hot holding at 135F or above. Observed the following cold foods out of temperature at the cold holding table near the hot holding table; 8lbs. of sour cream holding at 50F, 4lbs. of shredded cheese holding at 47F and 9 whole raw eggs (shell in tact) holding at 60.1F. Observed 30 cooked beef taquitos next to grill holding at 90.3F. Manager stated that he had made them that morning, but because the 4 hour time limit had past he was going to throw them out (they were not using time as a control). Corrected on site. See VC&D.

38. ADEQUATE VENTILATION AND LIGHTING; DESIGNATED AREA

POINTS 1	Compliance date not specified	Inspector Comments: Ensure hood filters are placed correctly in the hood to allow for proper ventilation. Observed hood filters in hood not fitting properly, 3inch gap on the left side of the hood.

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)

41. PLUMBING; PROPER BACKFLOW DEVICES

POINTS 1	Compliance date not specified	Inspector Comments: Repair/replace faucet handles. Observed faucet handles at 3 compartment sink and at prep sink not working.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

45. FLOORS, WALLS AND CEILINGS: BUILT, MAINTAINED, AND CLEAN

POINTS 1	Compliance date not specified	Inspector Comments: Ensure to have an air gap of at least one inch or twice the diameter of the draining pipe, whichever is greater. Observed drain pipe in the floor sink under the front cash register.

Clean and maintain floor sinks on a routine basis.
 Observed build up in floor sink under the soda dispenser next to the drive through window.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

48. FOOD WORKER CERTIFICATION

POINTS 2	Compliance date not specified	Inspector Comments: Obtain a valid San Bernardino County food worker card within 14 days. Please fax form to Environmental Health Services at 909-387-4272 within 14 days to avoid a billable re-inspection of \$245 per hour. Observed 4 food worker cards missing.

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
