<b>POINTS</b> <b>4</b>	Compliance date not specified	<b>Inspector Comments:</b> Properly and thoroughly wash hands in between glove uses. Gloves are not to be used for more than one task and shall not replace proper hand washing when needed.  Observed employee put on gloves to make a sandwich for customer and did not wash hands prior. Employee was instructed to properly wash hands.

**Violation Description:** Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

(113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

**7. PROPER HOT AND COLD HOLDING TEMPERATURES**

<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Maintain potentially hazardous foods for cold holding at 41F or below.  The following were observed out of temperature in sandwich prep table: 1. slices of deli ham at 49F 2. sliced of deli roast beef at 48F 3. slices of deli turkey at 49F  All deli meat have been in unit since the morning. It was determined the unit was in disrepair. Deli meat was voluntarily discarded. See VC&D.
