**Inspector Comments:** Observed walk in cooler to have heavy condensation build up, creating a large icicle structure directly on/in front of 3rd fan guard. Clean and maintain ice build-up in freezer on a routine basis.

**Violation Description:** All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. **Inspector Comments:** Observed employee's personal Chipotle food tray on top shelf of reach-in refrigeration unit and Chipotle chips on rack directly above unit. Observed multiple candies (in packaging) within the same unit. Ensure that personal items are not stored in any area used for the storage and preparation of food items sold at the facility. Designate a specific area, or container, for all employee personal food and items that is away from food preparation, handling and storage areas.

**Violation Description:** The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)
