7. PROPER HOT AND COLD HOLDING TEMPERATURES

POINTS 2	Compliance date not specified	Inspector Comments: Observed stack of vegan cheese slices in top section of reach-in cold-holding refrigeration unit being held at temperatures between 49-51°F. Employee stated that cheese had been placed in unit approximately 20 minutes prior. Ensure all potentially hazardous food is maintained at 41°F or below for cold holding Corrective action at time of inspection: Cheese was placed back inside refrigeration unit to drop temperatures back down to 41°F or below.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

9. PROPER COOLING METHODS

POINTS 2	Compliance date not specified	Inspector Comments: Observed a small, completely covered, plastic container of tofu in walk-in refrigeration unit measured at temperatures between 61-68F. Observed a second small, completely covered, plastic container of vegetarian beef in walk-in refrigeration unit measured at temperatures between 48-51F. Employee stated that food items had been prepared about 2 hours prior. Ensure that all potentially hazardous foods are rapidly cooled from 135F to 70F within the first 2 hours, and then further cooled from 70F to 41F within the next 4 hours. When placing food in the refrigerator to cool, containers should be loosely covered or uncovered to facilitate heat transfer from the surface of the food. Use thermometers to monitor cooling temperatures.
	Complied on 1/13/2015	

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

POINTS 2	Compliance date not specified	Inspector Comments: Observed the quat sanitizer level within the sanitizer bucket in the kitchen to be between 100-150 ppm while towels were in use. Ensure that the quat sanitizer concentration level is maintained between 200-300 ppm (or 100-200ppm for chlorine) within all sanitizer buckets at all times.
