A through search for additional activity, none was observed. A reinspection has been scheduled in one week (2/25/16). Complete the following by the reinspection:  -eliminate all dead and live cockroaches -clean evidence of infestation-remove all spotting and dead cockroaches stuck to the wall postings -seal all gaps, cracks, and crevices, especially along conduit on wall to the right of steam table -remove, to the extent possible, all cardboard -provide documentation of pest control performed in time between now and reinspection

(114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)
